TERMS AND CONDITIONS OF JAVN

Upon confirmation of enrollment, parents are required to pay the registration fee and medical fee. Please see our fee structure separately for more details.

- All term fees are non-refundable and non-negotiable as the expenses to operate the nursery remains the same throughout the year. Neither refund nor reduction can be given due to absences including leaving the nursery before the end of term. If your child is absent due to illness or on vacation during the term, alternative days cannot be accommodated.
- Please note that the registration of each child is treated individually.
- The registration fee is a one-off payment and is non-refundable.
- Medical fees are non-refundable and payable annually at the beginning of the academic year.
- All fees are payable within the date stated on the invoice.
- In an event your child cannot attend the following term, 30 days' written notice must be given to the nursery and no refund will be given.
- Cheque, cash, bank transfer and card payment direct at nursery are the accepted means of payment for all fees.
- The management reserves the right to exclude a child whose fees remain unpaid.
- Children must only attend the days for which they have been enrolled and if in case they have to go for an extra day due to unavoidable circumstances, kindly inform us in writing and settle at the reception.
- Please advise us in writing a month prior to the commencement of the next term if you wish to change the frequency of your child's attendance.
- I understand that this is a supervised programme, but the continued care and wellbeing of my child remains the responsibility of the parent.
- I agree to waive and release Jebel Ali Village Nursery (JAVN), and their affiliates, officers, members, agents, employees, other children and sponsoring agencies from and against any and all claims, injuries, liabilities or damages that may arise as a result of my child's participation in any and all JAVN activities, including the use of the play area and equipment.
- The nursery has the right to re-evaluate a child's registration.
- The decisions of the Nursery Management are final.
